Our Association is the parent organisation of: i) Ruttonjee and Tang Shiu Kin Hospitals; ii) Grantham Hospital. We are under the subvention of the Hospital Authority, but part of our expenses is underwritten by public donors. The Association established the "Peggy Lam Health Promotion & Education Centre" and our services include: health exhibitions, health talks, health promotion and education centre, TB research, hotline, elderly service, chinese medicine service and oral health education services.

Personal Information Collection Statement

Hong Kong Tuberculosis, Chest and Heart Diseases Association (The Association) is committed to protect your personal data (the Data). Your personal data is collected by the Association for the purposes of:

- 2. conducting research and generating statistics to enhance the Association's services and activities;
- 3. informing you of the latest services, campaigns, activities, recruitment of volunteers, fundraising appeals and issuing receipts and certificates relating to the Association via direct mail, email, phone and SMS;
- 4. complying with applicable laws or regulations.

Mandatory Information

The provision of the Data is voluntary. However, if you choose not to provide the Data to us, we may not be able to supply you with the relevant information or services or to process your request.

Transfer and Disclosure

Subject to your consent, the Association shall only transfer and disclose your personal data to service providers of the Association. The Association does not provide your personal data to any third party for the purposes of enabling that third party to market its own products or services to you.

Retention of Personal Data

All personal data will be collected and stored at the office of the Association for a reasonable period in accordance with our internal policy. Only authorized employees will be allowed to access relevant information.

Access and Correction of Data
